3. **PRESENTATION: STATEWIDE BICYCLE NETWORK ANALYSIS (20 MIN)**

Mr. Nate Evans will present information on the Statewide Bicycle Network Analysis (BNA) which was completed as part of the existing conditions analysis for the state Bicycle and Pedestrian Master Plan. The BNA is based on the bicycle level of traffic stress (LTS) and uses census data to determine the accessibility level of community assets using the very-low (bicycle LTS 0 and 1) and low-stress networks (bicycle LTS 0, 1 and 2). The analysis assigns a 'bikescore' to each census tract to better identify network gaps.

4. PRESENTATION: WALK & ROLL ANNE ARUNDEL (20 MIN)

Ms. Tanya Asman will share information about the County's updated Bicycle and Pedestrian Master Plan. The plan will be a vision for walking, bicycle and rolling (using a wheelchair, roller skates, a scooter, or any other active transportation device) in the County. The plan will build upon Move Anne Arundel!, the County's recently adopted Transportation Master Plan, as well as the previous 2003 and 2013 Pedestrian and Bicycle Master Plans. Its implementation will result in a connected network of streets and trails where it is safer, easier and more comfortable to get around outside of a vehicle.

6. PRESENTATION: PATAPSCO REGIONAL GREENWAY – GUINNESS TO SOUTHWEST AREA PARK PRELIMINARY DESIGN PROJECT (20 MIN)

Ms. Charlene Mingus will present information about the Patapsco Regional Greenway (PRG) – Guinness to Southwest Area Park Preliminary Design Project. In 2017, the Baltimore Regional Transportation Board (BRTB) approved a concept plan for the PRG. The Patapsco Regional Greenway envisions a 40-mile, shared-use trail running through the Patapsco Valley from Baltimore's Inner Harbor to Sykesville in Carroll County. To date, over 12 miles of the greenway have been completed. Now, the Baltimore Metropolitan Council (BMC), on behalf of the Baltimore Regional Transportation Board (BRTB) and in collaboration with Baltimore County is leading preliminary design of the Guinness to Southwest Area Park segment of the PRG which extends approximately 6 miles from Guinness Open Gate Brewery to Southwest Area Park and the MDOT MTA Patapsco Light Rail Station in Baltimore County.
