#### 3. PRESENTATION: BALTIMORE GREEN NETWORK PLAN AND ADDENDUM (20 MIN)

Mr. Kyle Leggs will present on the Baltimore Green Network Plan and the addendum that is currently being developed. The Plan includes a vision for an interconnected network of paths that expand access for walkers, joggers and bicyclists to the City's parks, water bodies, natural areas and other green spaces.

Ms. Virginia Olyniec will present an update on the Phase I Patapsco Avenue Bicycle and Pedestrian Bridge project. The bridge will provide a safe pedestrian and bicycle connection between the Cherry Hill neighborhood and the MDOT MTA Patapsco Avenue Light Rail Station. The bridge will also serve as a key connection for the expanding trail network in this area including bicycle improvements to Patapsco Avenue being led by Baltimore City and the PRG: Guinness to Southwest Area Park segment.

## 5. PRESENTATION: CHNGE TO REGIONAL BICYCLE FACILITIES INVENTORY (15 MIN)

Ms. Charlene Mingus will share information about changes to the regional bicycle facilities inventory data schema. BMC worked closely with member jurisdictions and MDOT SHA to develop an updated schema that incorporates more bicycle facility types and aligns with the MDOT SHA inventory of existing bicycle facilities and level of traffic stress (LTS) analysis while also simplifying the annual update process. The regional bicycle facilities inventory provides complete and uniform GIS data which is an important tool for regional and cross jurisdictional planning efforts including the upcoming Vision for a Regional Bicycle Network.

## 6. PRESENTATION: UPDATE ON RESILIENCE 2050 (15 MIN)

Mr. Zach Kaufman will share information on the public comment period for Resilience 2050: Adapting to the Challenge of Tomorrow, the next long-range transportation plan (LRTP) for the Baltimore region. Resilience 2050 contains a list of major transportation projects the region expects to implement from 2028 to 2050, taking into account anticipated funding levels through 2050.
