4. MARYLAND TRANSPORTATION PLAN

5. CHESAPEAKE BAY CROSSING

The BRTB will be briefed on the Chesapeake Bay Crossing Study: Tier 1 NEPA (Bay Crossing Study). The Bay Crossing Study is a National Environmental Policy Act (NEPA) study that will result in the identification of a preferred corridor alternative to address congestion at the Chesapeake Bay Bridge and evaluation of its financial feasibility. The Bay Crossing Study will evaluate current and future traffic demand across the Chesapeake Bay. (20 minutes)
