7. RECOMMENDED ACTION OF RESOLUTION #18-15

The BRTB will be asked to consider Resolution #18-15 for approval. This resolution involves written provisions for cooperatively developing and sharing information related to transportation performance data, the selection of performance targets, the reporting of performance targets, and the reporting of performance to be used in tracking progress toward attainment of critical outcomes for the region, as well as the collection of data for the state asset management plan for the National Highway System. www.baltometro.org/BRTB/BRTBRes18-15.pdf

8. RECOMMENDED ACTION OF RESOLUTION #18-16

The BRTB will be asked to consider Resolution #18-16 for approval. This resolution involves the adoption of two performance targets related to the CMAQ program for the Baltimore urbanized area. The targets are: (1) annual hours of peak-hour excessive delay per capita and (2) percent of non-SOV travel. Per federal requirements these targets for the Baltimore urbanized area will be the same for both the state and the region.
