5. RECOMMENDED ACTION ON RESOLUTION #21-10 (10 MIN)

The BRTB will be asked to consider Resolution #21-10 at the request of MDOT MTA to update funds in the 2021-2024 TIP in its Small Urban Transit Systems Capital Assistance project. Funds are changing to match the awarded versus estimated preventive maintenance funding for Carroll County and to add federal funds for the City of Annapolis.

6. RECOMMENDED ACTION ON RESOLUTION #21-11 (10 MIN)

The BRTB will be asked to consider Resolution #21-11 at the request of MDOT SHA to add a new project to the 2021-2024 TIP funded with a repurposed congressional earmark. The project will fund engineering for a sidewalk where none currently exists along MD 835C in Stevensville.

7. RECOMMENDED ACTION ON RESOLUTION #21-12 (10 MIN)

The BRTB will be asked to consider Resolution #21-12 at the request of MDOT SHA to add a new project to the 2021-2024 TIP replacing two poorly rated bridges along U.S. 1 near Bel Air.
