## 1. APPROVAL OF AUGUST 7, 2018 MINUTES

#### 2. RECOMMENDED ACTION ON RESOLUTION #19-5

The TC will be asked for its recommendation to the BRTB on Resolution #19-5. This involves adding two projects to the 2015 Regional Transportation Plan, known as *Maximize2040*, and the FY 2019-2022 Transportation Improvement Program (TIP) as well as the associated air quality conformity determination. Both projects on I-95 are sponsored by the Maryland Transportation Authority. One is for express toll lanes northbound on Section 200 and the other is for Access Improvements in the area of Port Covington.

### 3. RECOMMENDED ACTION ON RESOLUTION #19-6

The TC will be asked for its recommendation to the BRTB on Resolution #19-6. This involves adding a new grant-funded project to the FY 2019-2022 Transportation Improvement Program (TIP) at the request of the Maryland Transit Administration.

### 4. RECOMMENDED ACTION ON RESOLUTION #19-7

The TC will be asked for its recommendation to the BRTB on Resolution #19-7 to endorse the Financial Forecast for Maximize2045: A Performance-Based Transportation Plan.

#### 5. RECOMMENDED ACTION ON RESOLUTION #19-8

The TC will be asked for its recommendation to the BRTB on Resolution #19-8 to reconcile the FY 2018 carryover funding into the FY 2019 UPWP.
