## 3. MDOT MTA TRANSIT PRIORITY INITIATIVE (30 min.)

Building upon the <u>infrastructure improvements</u> associated with the launch of BaltimoreLink, MDOT MTA is working with local jurisdictions to increase bus reliability, speed and passenger safety throughout the BaltimoreLink system. MDOT MTA has pursued a data-driven approach to identify opportunities in the system, focusing on reliability, bus speeds, and travel delays at bus stops. MDOT MTA staff will brief the committee on this initiative. The BRTB is looking to use a similar approach to improve service along corridors utilized by Locally Operated Transit Systems (LOTS) in the Baltimore region.
