MINUTES

The meeting was called to order at 5:35 P.M. by PAC Chair, Mr. Eric Norton.

1. INTRODUCTIONS AND WELCOME OF NEW PAC MEMBERS

Mr. Norton welcomed these new members to their first meeting of the Public Advisory Committee (PAC): Mr. William Cowan, Ms. Tiffany Davis, Ms. Janet Eveland, Mr. Benjamin Groff, Ms. Yvette Hicks, Mr. Charles Lawrence, Mr. Zack Vacovsky, Mr. Paul Verchinski, and Mr. Jedediah Weeks.

He also introduced the 2016 Vice Chairs: Ms. Angela Jones and Mr. Kevin Engler. The Baltimore Metropolitan Council (BMC) provides the PAC staff support, with the primary contact being Ms. Monica Haines Benkhedda. Tonight, Mr. Todd Lang, Director of Transportation Planning, attends as well. Mr. Norton invited members to introduce themselves and share their background.

2. OVERVIEW OF THE BALTIMORE REGIONAL TRANSPORTATION BOARD

Mr. Lang provided members with an overview of the BRTB and its responsibilities as a Metropolitan Planning Organization (MPO), as well as the typical work products, such as the upcoming development of the FY 2018-2019 Work Plan and Budget, the short-range Transportation Improvement Program (TIP) and next Long-Range Transportation Plan.

Ms. Haines Benkhedda shared ways the PAC and other members of the public can be involved. Ms. Haines Benkhedda emphasized the importance of PAC members staying connected to BMC/BRTB social media channels and e-newsletters in order to be aware of news and upcoming action items. She also asked that members share information with their own networks about opportunities for public involvement with BRTB and BRTB member agencies such as MTA, SHA, or local planning efforts.

New members were also encouraged to visit <u>baltometro.org</u> to watch a video guide to metropolitan transportation planning and to or to access recent BRTB/PAC minutes, presentations, and calendar of upcoming events. Lastly, Ms. Haines Benkhedda noted that the PAC has a Google Group for PAC members to share information and collaborate on documents. She asked that each member contact her if they are unable to access this group or needed assistance in connecting.

Mr. Norton informed new PAC members that a proposal for a new Ad-Hoc Transportation Equity Subcommittee was presented to the members in 2016. The proposal was distributed to new members and Mr. Norton asked that all members be prepared to vote at the February meeting as to whether or not they believed the PAC should move forward with the development of an Ad-Hoc Equity subcommittee.

Assignments for the subcommittees will be determined shortly, with Mr. Norton remarking that not all members are able to serve on their 1st choice for subcommittee as many more individuals have selected the Policy subcommittee as their first choice. Mr. Norton will email all members to ask for volunteers willing to serve on the Public Involvement subcommittee this year. Any members who would be interested in serving on the Ad Hoc Equity committee were also asked to notify him.

2019 LRTP – Suggested New Strategies

Suggested new strategies from BMC staff and Queen Anne's County (all changes shown in red). These new strategies are intended to strengthen planning related to system redundancy and evacuation routes, to incorporate a new planning factor related to tourism that was added in the FAST Act, and to acknowledge the need to consider emerging vehicle technologies and shared mobility options in project planning and programming.

GOAL: Improve System Security – Provide a secure traveling environment for everyone; improve the region's ability to respond to natural and man-made disasters.

- Increase redundancy in the overall system. Where this is not possible, look for alternatives to add capacity (including adding capacity through operational improvements) to existing corridors or facilities.
- Review evacuation routes and identify points of limited capacity. Consider alternatives that would improve traffic movement through these points of limited capacity in emergency situations (e.g., improving traffic operations, identifying alternative routes, expanding existing roadways).

GOAL: Promote Prosperity and Economic Opportunity – Support the revitalization of communities, the development of activity centers, and the movement of people, goods, and services.

• Invest in new and improved transportation assets and facilities that promote tourism and the movement of tourists within and through the region. This includes (1) improving roadway, transit, pedestrian, and bicycle access to regional and local tourist attractions, (2) analyzing peak travel volumes and times in key tourism corridors, and (3) improving and promoting information systems (e.g., signage, bus service information, smartphone applications) that visitors can use to reach destinations easily and safely.

GOAL: Promote Informed Decision Making– Ensure that adopted transportation policies and performance measures guide the regional decision making process and improve and promote decision-making tools for travlers.

- Coordinate transportation investment with state planning policies and local plans regarding tourism, growth, and development (e.g., PlanMaryland).
- Continue to plan for and consider the effects of emerging technologies and increasing vehicle/infrastructure connectivity when moving projects through the project development process. For example, consider the long-term effects of, and infrastructure needs related to, connected and automated vehicle use on traveler safety, roadway congestion, and land use when planning for new and improved transportation facilities. Make project scopes more flexible as needed to accommodate the potential effects of such emerging technologies.
- Continue to plan for and consider the effects of alternative means of travel (e.g., ride hailing services, microtransit services, ridesharing, etc.) on traveler safety and security, roadway congestion, and land use.
- Continue to improve information systems (e.g., signage, bus service information, smartphone applications) that all travelers can use to reach destinations easily and safely.

Mission and activities for PAC Ad Hoc Transportation Equity Subcommittee

The Ad-Hoc Transportation Equity Subcommittee will consist of at least five voting members and will function as subcommittee to review regionally significant land use and transportation issues, plans and programs, including the Unified Work Plan, the Long Range Transportation Plan, and the Public Participation Plan.

This committee will focus on reviewing regional transportation plans and programs through the lens of equity and environmental justice so as to advocate for the development and implementation of policies and plans that address the crucial role of transportation in providing access to opportunity, schools and health care for minority, vulnerable and low-income populations. Activities include, but are not limited to:

- Support the capacity of the PAC to apply the lens of equity and environmental justice to public participation efforts and transportation investments, policies and plans through relationship-building with transportation equity groups and coordination of presentation and speakers.
- Examine the impact on minority, vulnerable and low-income populations of proposed and current policies, projects, and programs in terms of increased transportation options, reduced isolation, improved affordability and increased access.
- Review measurable outcomes and if those outcomes represent transportation equity for minority, vulnerable and low-income populations.

CARDSTORMING - JANUARY 11, 2017



INTRODUCTION

On January 11, 2017, the Public Advisory Committee (PAC) met to welcome new members and discuss its goals and potential activities for 2017. In order to facilitate this discussion, Ms. Monica Haines Benkhedda led the group in a "Cardstorming" exercise and discussion.

To begin, each person was given a stack of post-it notes and asked to finish this statement: *In order to be most effective, in 2017, the PAC should focus on...*

All members then wrote down all of their thoughts and ideas. Following this, all of the post-it notes were put on the wall. Through the discussion process ideas were sorted, clustered, and categorized.

SUMMARY OF RESULTS

The full results of this exercise and discussion are attached; however, the group categorized their ideas into several key areas. These are as follows:

Do more on Equity

- o Equity and inclusion in transportation decision-making
- o Talking about funding inequity w/r/t transport vs. automobile public investments

Advocate for better data availability and communications

Advocate for decision-makers to listen

- o Providing overview of current conditions some folks may be more knowledgeable of certain areas
