MINUTES

Mr. Eric Norton, Chair, called the meeting to order at 5:38 P.M.

1. PRESENTATION: HARFORD TRANSIT LINK

Mr. Gary Blazinsky, Harford Transit Administrator and BRTB member, spoke about recent updates to Harford Transit LINK including: streamlined schedules, extended weekday hours and added bus stops.

Each year, Harford Transit LINK provides over 330,000 trips on its six fixed-route and demandresponse transit service to connect to local employment and activity centers, as well as to link with MDOT MTA's bus and MARC train services. The agency recently revamped the entire route and stop system, as well as launched the Token Transit and RouteShout 2.0 smart phone apps, installed 6 bus shelters in Aberdeen and Bel Air, made some technology and infrastructure improvements.

These changes resulted in improved on-time performance, reduced passenger wait time by 33% and reduced transfer time by scheduling buses to arrive and depart within 10 minutes at major transfer points. In addition, Mr. Blazinsky outlined the agencies initiatives for 2020 and beyond, including Saturday service, upgrading advance reservation demand-response service to same-day service, and utilizing a variety of funding sources to upgrade vehicles, signage, bus stops, and transit facilities. He also shared Harford County's participation in the Choose Civility program and efforts to work with employees to <u>identify new ideas</u>, <u>share feedback</u>, and <u>collaborate</u> to improve service to riders.

2. MAXIMIZE2045 UPDATE

Mr. Terry Freeland provided an update on *Maximize2045*: A *Performance-Based Transportation Plan*. Staff continue to review the list of projects submitted for consideration in Maximize2045 and conduct travel demand modeling and air quality analyses. Once the scoring and analysis

is completed, the BRTB will consider the mix of projects and release the list of projects along with a draft plan for public review in May and June.

Staff agreed to send to the subcommittee which will review at their next conference call on April 25 at noon.

- Update on <u>Central Maryland Regional Transit Plan (RTP)</u> MDOT MTA hosted the first commission meeting for the RTP on March 25, 2019 at BMC. PAC members discussed their role in the RTP development process and any potential conflicts of interest given members' participation in various organizations or coalitions also involved in the RTP process. This led to a discussion of the PAC's mission and role. Members asked to further discuss this at a future meeting. For now, those members currently participating will do so and share information with other members. The next RTP meeting is set for Thursday, April 25 at BMC.
