About the TA Funding



- The FAST Act eliminated the TAP Program as established in MAP-21
- Under the FAST Act, TAP and Safe Routes to School Programs were merged and replaced with a set-aside from the Surface Transportation Block Grant (STBG) Program
- A portion of the TA set-aside is suballocated to metropolitan areas over 200,000 in population
- The TA Program has 10 eligible categories
- Funding available: \$2,138,046 and \$528,493

TA Recommendations - Summary



- Staff recommendations for Projects 1 14 utilize \$615,120, leaving \$1,522,926 on the table.
- For Project 15, staff recommends matching the \$528,433 with an equal amount of the remaining Baltimore area funds, leaving \$994,493 on the table.
- The state has \$10M for all non-MPO and 2nd round MPO projects.
