# 2020-2023 TIP: Changes from Draft



- Ridesharing: Increase FY 2020 CMAQ from \$1.346 million to \$1.55 million. An increase of \$204k.
- SCMAGLEV: Adjust federal matching split from \$7.273 million/\$10.133 million to \$13.9 million/\$3.48 million
- DC-to-Baltimore Loop Project: Removed from TIP. Will now be reflected in statewide plans only.
