### Key Dates – 2021 Legislative Session

- January 12 Legislature Convenes
- February 7 & 11 Senate & House Introduction Deadlines – (After which bills are referred directly to Rules Committee)
- March 7 & 11 Final Date for Introduction of Bills without Suspension of the Rules in the Senate and House
- March 15 Committee Reporting Courtesy Deadline (bills should be moved by committees of origin)
- March 21 Crossover Deadline (Bills must be passed by chamber of origin. If not, then referred to Rules)
- April 4 Budget Bill Passage Deadline
- April 11 Sine Die All bills must pass or die today.

# 2022 Transportation Legislation – Major Categories







### SAFETY

### HB254/SB874 – Vision Zero Implementation Act of 2022

- Del. Palakovich Carr & Sen. Waldstreicher
- Requiring SHA to conduct infrastructure review of each bike-ped fatality occurring at a SHA intersection
- Passed 3<sup>rd</sup> Reading with Amendments & crossed over in both houses

## HB656/SB880 – Safe Access for All (SAFE) Roads Act of 2022

- Del. Charkoudian/Sen. Waldstreicher
- Requiring MDOT to recommend and implement design elements for bike/ped safety in certain projects...
- <u>House Passed With Amendments</u>
- <u>Senate Never left Committee</u>





### **ENVIRONMENT**

### HB10/SB61 MTA – Conversion to Zero Emission Buses

- Del. Korman/Sen. Zucker
- Requiring MTA to provide workforce training for the safe repair and maintenance of electric fleet vehicles.
- Passed 3<sup>rd</sup> Reading with Amendments & crossed over in both houses

## HB894 – Transportation Electrification & Modernization (TEAM) Act

- Administration Bill
- Extending the duration of the Electric Vehicle Recharging Equipment Rebate Program and limiting amount of rebates to businesses and households.
- Never left committee

### HB1391 – Clean Cars Act of 2022

• Del. Fraser-Hidalgo

BMC

- Extending the vehicle excise tax credit for the purchase of certain vehicles.
- <u>Passed House with Amendments First Reading in Senate</u>



## **FUNDING – HIGHWAY USER REVENUE**

## HB410/SB400 – Transportation – Highway User Revenue - Distribution

- Administration Bill
- Altering, beginning in 2025, amounts of certain HUR grants appropriated to jurisdictions each year.
- Never left committee in either chamber

## HB1187/SB726 – Highway User Revenues – Revenue and Distribution

- Del. Anderton/Sen. McCray
- Altering, beginning in 2020, the amounts of capital grants required to be appropriated to jurisdictions.
- Passed House with Amendments Stayed in Committee in Senate

## HB1362 – Baltimore City – Use of HUR for Traffic Functions & Enforcement - Modification

- Del. Prettyman/Sen. McCray (Request of Baltimore City)
- Altering certain limitation applicable to Baltimore City related to the use of HUR to pay or finance costs related to traffic functions and enforcement.
- Passed House with Amendments Stayed in Committee in Senate





## **FUNDING – MDOT and CTP**

#### SB187 – DOT – Grant Anticipation Revenue Vehicle Bonds

- Administration Bill
- Repealing a requirement that the Capital Debt Affordability Committee include certain debt secured by federal aid.
- <u>Never left committee</u>

## HB0891/SB593 – MDOT & Spending Affordability Committee - Reports

- Del. McIntosh/Sen. Guzzone
- Requiring MDOT, on submission of budget bill, to provide certain legislative committees a report on the cost of certain projects and to include certain information in the CTP.
- Passed both chambers unanimously without amendment

## HB1322 – Operating Budget – CTP and Unanticipated Federal Funds

- Del. McIntosh/No Crossfile yet.
- Requiring the financial forecast that supports the CTP to include \$35M for certain changes in revenue, prohibiting certain expenditure of federal funds in FY22 unless money is used for certain purposes.
- Never left committee





## LOCAL BILLS

#### HB73 – Complete Streets & Safe Routes to School Programs -Funding

- Del. Lewis
- Requiring Baltimore City to spend balance of fines collected from traffic monitoring systems on SHA Safe Routes to School Program or Complete Streets Program
- Passed House without Amendment in Senate

#### HB632 – East West Corridor Transit Study Requirements

- Del. Rosenberg
- Requiring MDOT to promptly undertake steps necessary to complete design, engineering and NEPA to secure a record of decision for the Red Line
- Passed House With Amendments require receipt of federal funds

## HB1056/SB862 – Baltimore City – MTA – Transit Services for Public School Students

- Del. Lierman/Sen. McCray
- Requiring MTA to provide ridership on transit vehicles to provide free ridership to certain BCPS students.
- Passed Senate with Amendments Bill is in the House





## **MARYLAND TRANSIT ADMINISTRATION**

#### HB438/SB463 – WMATA Dedicated Funding Amendment Act of 2022

- Del. Korman/Sen. Feldman
- Requiring the appropriation in the annual budget for WAMATA to equal FY22 and be increased by 3% each year
- Passed both Chambers with Amendments in the House to bump increase start by four years (2022 to 2026)

#### HB778/SB514 – Maryland Regional Rail Transformation Act

- Del. Solomon/Sen. Beidle
- Requiring MTA to establish investment programs for enhancing certain MARC Lines.
- <u>Passed both Houses with Amendments</u>

## HB1336 – Greater Baltimore Transit Governance and Funding Commission

- Del. Bridges
- Establishing the Greater Baltimore Transit Governance & Funding Commission.
- Passed House with Amendments





## **OTHER BILLS OF NOTE**

## HB326/SB359 State Finance – Prohibited Appropriations – MAGLEV

- Del. Williams/Sen. Pinsky
- Prohibiting the State and certain units of the state from using any appropriation for MAGLEV in the state.
- Never left committee in either chamber

#### HB710/SB516 Equitable & Inclusive TOD Enhancement Act

- Del. Lewis/Sen. Augustine
- Altering the More Jobs for Marylanders Program to allow certain businesses located in certain TOD developments to qualify for benefits. Establishing a TOD capital grant and revolving loan fund.
- Second Reading Passed Senate with Amendments As of 8:05 pm on 3/21

#### HB1324 – Maryland Rail Investment Act of 2022

- Del. Korman
- Establishing the MD Rail Authority; adding ED of the Rail Authority as an ex officio member of MdTA
- Bill never left committee





### **30 Day Repeal of Gasoline Tax**



### HB1486/SB1010 - Motor Fuel Taxes - Tax-Free Period

Providing that, for the 30-day period beginning on the effective date of the Act, certain motor fuel taxes that would otherwise be imposed do not apply; requiring the Comptroller to pay a refund advance of motor fuel tax to qualifying retailers under certain circumstances; requiring a qualifying retailer to pay certain motor fuel tax to the Comptroller within 30 days after the expiration of the tax-free period; authorizing the suspension of certain licenses of a qualifying retailer under certain circumstances; etc.



Effective on March 18, 2022
