Overview



- When MTA obligates a grant, we need to have the funds shown in the year of obligation
- MTA is taking actions necessary to obligate a number of grants





RAISE East-West Transit Priority Project



Background

- The RAISE Project proposes enhancements to the CityLink Blue and CityLink Orange lines Including transit priority elements, accessibility improvements, and customer amenities.
- Obligating FY 2025 RAISE Grant.

Benefit

• To provide faster, more reliable transit and improved pedestrian safety along the 20-mile corridor.

Apportionment

 This amendment will shift \$22M in RAISE funds and \$32.4M in local/state funds from FY 2024 to FY 2025 to reflect year of obligation.

Schedule

• The project will finish design in early 2025 and then enter procurement depending on execution of paper grant agreement with FTA.





Patapsco Avenue Pedestrian/Bicycle Bridge



Background

- Project will provide a direct and safe connection from the Cherry Hill neighborhood to the Patapsco Avenue Light Rail Station.
- Obligating FY 2020 TA funds and FY 2024 congressionally directed spending.

Benefit

• This project will improve access and safety for users of the Patapsco Avenue Light Rail Station and bus loop.

Apportionment

 This amendment will obligate previously awarded \$624,000 FY 2020 TA funds in FY 2025 and show an FY 2026 obligation for the \$5M FY 2024 congressionally directed spending.

Schedule

• Design is underway.





Cloud Based-Signal Priority



Background

- Project will install cloud-based transit signal priority solutions at approximately 90 intersections on four high frequency bus lines.
- Obligating FY 2025 SMART grant funding.

Benefit

 This project will improve bus speeds and reliability while reducing installation and maintenance costs compared to the current Transit Signal Priority (TSP) system.

Apportionment

• This amendment will obligate \$1.276M in SMART funds to FY 2025.

Schedule

 This project kicked off in summer 2024 with a period of performance of 18 months per grant requirements. Implementation will take place in FY 2025 with a final report in FY 2026.







Background

- This project will construct raised bus stop platforms on Maple Lawn Boulevard, John Hopkins Road, and Downtown Columbia
- The stations will provide level-boarding for other transit routes as identified in the Howard County Transit Development Plan
- Each station will provide convenient and ADA accessible bicycle and pedestrian access

Benefit

- This project will support an extension of the US 29 Flash BRT System
- Improve transit operations at the new bus stops
- Improve transit service to the Maple Lawn community, the John Hopkins Applied Physics Laboratory campus, and Downtown Columbia





Apportionment

This amendment adds \$750,000 in Community Project funding and \$629,000 in match from Howard County for construction.

Schedule

Planning and Design is underway by Howard County and anticipated to be completed in 2025. Construction is estimated to take approximately 1 year.

Operations are expected to start in early 2026.
