2020 RTP: Process and Participation





The RTP was intended to:

- Lay out a 25-year vision for public transportation in the Central Maryland Region.
- 2) Identify ways to
 - Improve existing MTA transit
 - ii. Better coordinate transit region-wide and across providers
 - iii. Show places/corridors that would most benefit from new infrastructure investments
- 3) Provide an opportunity to coordinate transit planning with local land use and other statewide transportation planning efforts

2020 RTP: Process and Participation

The RTP was produced collaboratively

- The formation and involvement of a Commission was mandatory, and these meetings meaningfully informed plan goals objectives and methodologies
- LOTS, agency, and local government representatives were involved regularly, and have remained engaged through implementation
- Extensive public engagement informed both priorities and methodologies, setting a durable baseline understanding for the RTP and its planned updates





2020 RTP: Goals and Objectives

The RTP had three broad goals:

- Optimize existing services
- Plan for their
 integration with
 future services
- Enhance fiscal sustainability.

Six key Objectives were associated with these goals.





Each of the objectives had strategies for its implementation

- Progress has been made on all strategies identified in the 2020 Plan's Five-Year Implementation Plan
- Of the 34 strategies in the Five-Year Implementation Plan:
 - 7 have been completed
 - Others are in progress or continual commitments
- Please read through the plan and consider whether changing conditions, shifting priorities, or progress on parallel efforts mean additional strategies should be considered; MTA will do the same and this will be a topic of discussion at a further meeting.

2020 RTP Corridor Progress

- Early Opportunity Corridors have made progress since 2020
 - RAISE East-West (13,16)
 - Red Line (16, 17)
 - FLASH BRT (27)
 - East Baltimore County Access Study (18)
- North-South Feasibility Study (1,6)
- Analysis conducted on some Mid- and Long-Term corridors through:
- North-South Feasibility Study (7,8)
- East Baltimore County Access Study (5)
- BWI to Columbia Pilot Feasibility Study (25)





RTP Corridors: Plan to Update

There have not been drastic changes in transportation and land use in the region since 2020, but it is still worthwhile to update our understanding of the transit market

Discussion Question: Updating Corridor Analysis

In addition to the factors mapped on previous slides, the 2020 analyses to identify the Corridors included:

- Density and growth of population
- Density of employment and other destinations
- Travel flows for work and non-work trips
- Existing transit frequency and span of service
- Existing transit ridership and growth trends

Destinations Analyzed

- Employment
- Retail & Restaurant
- Healthcare
- Social Assistance
- Education
- Government

Are there additional factors we should consider while giving the corridors a fresh look?
