## **PARKING OVERVIEW**



- Not enough on-street parking turnover
- · Overall, sufficient number of parking spaces
- Courthouse Lot is underused except during events
- · Vehicular access into some lots is challenging
- · Walking routes to/from lots is unclear

#### Proposed improvements from the Watershed Master Plan:

- Explore valet parking with private sector support
- Consider running a shuttle to Lower Main from upper lots
- Study the potential for the following parking measures:
- Parking Fees
- Time Restrictions
- Parking Structure
- Designated Employee Parking
- Creation of a Parking Authority
- Include EV accommodations

## **PARKING UTILIZATION**



Parking activity was the lowest in the 10AM-11AM hour. Thirty-one (31%) of all off-street spaces were occupied.

Ellicott City

Off-street parking utilization peaked in the early evening with some lots completely full, but overall utilization reached 70% capacity.

# Create designated employee parking in Lot F, Lot G, and the Courthouse Lot

Business employees should be encouraged to park in Upper Main lots Employees should not be restricted to parking in a specific location

# Add 15 or 30 -minute time restrictions for Main Street's on-street parking

Main Street's street parking should be reserved for quick trips or pick-up/drop-offs

We should keep the 2-hour limit for street parking on Main Street

## Construct a parking garage for additional parking in either Lower or Upper Main

Old Ellicott City needs a parking garage to relieve parking concerns

A parking garage is not necessary

## Utilize technology to monitor parking availability & send data to website or signs

Incorporate digital counters in parking lots to provide real-time info on parking availability Static signs could help, but technology and/or digital signs at lots are not necessary

## Deploy a shuttle service on weekends from parking lots to Lower Main

Shuttles will help improve use of upper lots by easing access to/from Lower Main Shuttles are unnecessary to resolve the parking challenges in Ellicott City

## How do you feel about these potential sign

#### upgrades?

Rename parking lots to be more intuitive. Parking Lot "D" could be renamed "Town Center" and the remaining lots could be renamed with streets or other adjacent landmarks.

Provide "Lot Full" status for Lot D and other larger lots at primary road entries such as Ellicott Mills Dr. and Frederick Road.

Update parking signage to also show various amenities such as EV parking stalls, and connections to hiking/biking trails.

#### **Optimize and Manage Existing Inventory**

Recommendations in this category help provide users with greater information of parking locations and availability, greater access to parking, and better management of these resources.

Inventory management recommendations include:

- · Parking information signs and parking counters, to help identify lots with available supply.
- Downtown parking shuttle
- **Employee parking incentives**
- Improved parking enforcement
- Parking management program

#### **Proactively Manage Curbside Activity**

Better management of the curbside lane helps optimize parking availability, support the area's loading needs, and better address ADA parking requirements.

Curbside lane recommendations include:

- · Introduce dynamic on-street parking to accommodate both loading and private vehicle parking
- Convert select on-street/2-hour parking to shorter-term parking/30 minute parking
- Add on-street parking by removing loading zones, adding ADA parking spaces where demand is highest and feasible
- Widen sidewalks by removing on-street parking in areas where safety is a higher concern than parking access

#### Add Convenient Bike Parking

- Install bicycle racks at key locations along Main Street and within major parking lots to accommodate bicyclists and offer priority to alternative transportation users
- Bike racks to meet Historic Preservation Commission guidelines, incorporating a black metal hitch and post style
- See map at right for specific locations

#### Site-Specific Bike Parking Recommendations

- G Add Bike Parking in Future Park; As part of the new redevelopment at the southwest corner of Main Street and Maryland Avenue, add substantial bike parking to accommodate 6-12 bicycles.
- G Add Bike Parking to Main Parking Lots; In order to complement other bicycle parking locations, add bike racks to Parking Lots A, B, D, and E.

#### Improve the User Experience

- Parking facilities should function as a positive, marketable asset for downtown.
- Parking management can help coordinate programs and events through:
- Improved physical signage
- Focused marketing
- Strong web-based information programs

#### **Establish Customer Friendly Enforcement**

Re-orienting enforcement policies and practices can be very helpful in reaching the Howard County and Baltimore County parking goals.

- The enforcement team should re-orient to:
- · Support the creation of a customer-oriented parking system
- Develop sensible and reasonable parking regulations that are easy to understand and easy to manage
- Modernize and adopt new parking technologies
- Establish a data-driven, flexible parking system that can adapt over time

### Build Parking Strategically and Sparingly

- Even during existing peak demand, many parking spaces are available—but drivers can't find them, don't want to use them, or are not aware they exist.
- Recommendations should be prioritized to address current issues related to on-street demand and time-limit violations, fragmented signage, and lack of technology and information systems. Though future development within Downtown Ellicott City is limited, any such development has the potential to generate new off-street parking supply and demand.
- As noted in earlier recommendations, the County should:
- Revise the parking code
- Facilitate agreements with developers to ensure that new parking supply is shared and publicly available to the greatest degree possible.

#### Main Street Corridor Network Improvements

These recommendations are located along Main Street/ Frederick Road between Parking Lot B and Ellicott Mills Drive. Most of the recommendations in this category pertain to the pedestrian experience in the historic downtown.

Network Improvements Outside of the Main Street Corridor

These recommendations primarily address gaps and provide opportunities in the multimodal network just outside of the Main Street Corridor. Adopting these recommendations will improve pedestrian and bicycle travel conditions to and from Main Street.

#### Ellicott City and Oella Pathways and Trails

This grouping includes larger, more long-term investments that serve the larger Ellicott City and Oella areas and expand the multimodal network well beyond the Main Street Corridor.

# MULTIMODAL RECOMMENDATIONS





### Multimodal Policy Recommendations

These recommendations are not location-specific and can apply across the study area.

Multimodal policy recommendations include:

• Sandwich Board Regulations to be codified by the Howard County Council to define where on sidewalks businesses can deploy freestanding, sandwich board-style signs to help keep the pathway clear for pedestrians

• Enhanced Parking Enforcement Around Multimodal Facilities to ensure pedestrian and bicycle facilities such as sidewalks and bike lanes are not encroached upon by parked cars

# **WAYFINDING & SIGNAGE** RECOMMENDATIONS





#### A | New Parking Signs

This recommendation adds and replaces

existing parking directional signs with

new signs containing larger text and

simpler messaging.

#### **B** | Parking Lot Identity Signs

#### This recommendation adds four sided parking lot identity signs to help identify the lots for both vehicles and pedestrians

This recommendation adds signs to help vehicles find parking when lots are full. Included are signs to direct vehicles from Lot D to Lots F/G when Lot D is full and to direct vehicles to Courthouse parking when Lots F/G are full.

#### D Upgrade Parking Signs with Lot Full Status

This recommendation adds lot "OPEN" and "FULL" displays to existing parking signs at the parking lot entrances and entry roads into town

#### E | Upgrade Monument Entry Signs

This recommendation upgrades the "Welcome to Historic Ellicott City" monument signs at the east and west entrances on Main St. F Add Pedestrian Directory Signs

This recommendation adds directory signs at the walking path from the lot exit to the street. The directory can incorporate static elements as well as include an insert section for events or for a list of business that can be updated periodically.
