UPDATE ON PUBLIC COMMENT PERIODS May 2024

Federal Certification of the BRTB

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) want to hear what committee members and other key stakeholders think about how well the BRTB follows guidance for transportation planning. This process is called **federal certification** and it happens every four years to make sure we, as the MPO, are staying on track and implementing recommendations.

Over the past four years we have reached thousands of people to share information and get feedback on dozens of projects, plans and other work to plan the future of transportation in our region.

So far, we've heard from 38 people who shared 200 survey responses and 16 comments. Comments are welcome, online through **Tuesday, May 7.**

PRG Stoney Run (Phase 2)

We are continuing to work to design the Patapsco Regional Greenway - Stoney Run Trail and we are seeking community feedback!

In January, we launched the design process and heard from community members about their ideas for features, concerns about the trail, and suggestions for making the trail beneficial for everyone.

Now, we are eager to hear from folks about 4 different options for where the trail should go.

We will be hosting a community meeting on May 22 at 6 p.m. in Linthicum. Stop by there or let us know what you think by June 5 what you think.
