Other facts:

- The contract term will be effective from the July 1, 2024 through June 30, 2027, with three additional three-year terms.
- All pricing will remain firm throughout the contract term.
- FCPS is acting as lead agency under this RFP, with four Maryland school systems combining their needs with ours. The intent was to create an RFP that will leverage the aggregate number of students from all participating organizations in an attempt to receive lower pricing.
- Mindprint Learning Inc. was disqualified as their documentation stated their solution did not meet the minimum requirements.
- This contract will be administered by Dr. Jessica Reinhard, Advanced Academics Supervisor, Curriculum, Instruction and Innovation.
- 3. Source of funding: Contingent upon Board approval of FY25, FY26 and FY27 Operating Budgets.
- B. **Recommendation**: Staff recommends that RFP 24MISC8, Cognitive Ability Testing Software be awarded to Riverside Assessments, LLC dba: Riverside Insights, per the attached bid tabulation.
