AGREEMENT FOR SERVICES # 4545-OB

THIS AGREEMENT, made this 30 day of July, 2012 by and between Anne Arundel County, Maryland (the "County"), and Glen Burnie Transmission, Inc. (the "Contractor").

WHEREAS, the County issued IFB No. 13-038, entitled "Transmissions, Automotive" a copy of which is attached hereto as Attachment A and is incorporated herein and made a part hereof;

WHEREAS, copies of the Contractor's technical proposal, if any, and cost proposal are attached hereto as Attachment B;

WHEREAS, having completed the Procurement process in accordance with Attachment A and the Anne Arundel County Code, the County is awarding the resulting contract to the Contractor; and

WHEREAS, it is the purpose of this Agreement to describe the formal rights and obligations of the parties;

NOW, THEREFORE, WITNESSETH that, for the consideration herein indicated, and in consideration of the mutual promises and covenants set forth in this Agreement, the Contractor and the County agree as follows:

1. The Contractor shall perform services described and outlined in Attachments A and B to this Agreement, which are incorporated herein and are made a part hereof (the "Work").

2. The County and the Contractor shall have all rights and obligations set forth in Attachments A and B. If any term of this Agreement conflicts with any term of Attachments A or B to this Agreement, then the term of this Agreement shall control. If any term of Attachment A to this Agreement conflicts with any term of Attachment B to this Agreement, then the term of Attachment A shall control.

3. The County shall pay the Contractor in accordance with the fee schedule set forth in Attachment B to this Agreement. Services under this Agreement shall be performed pursuant to Blanket Order Release Purchase Orders issued by the Purchasing Agent. The Finance Officer shall certify availability and encumbrance of funds for each Blanket Order Release Purchase Order issued pursuant to this Agreement, and no payment shall be made to the Contractor absent such certification.

4. If the term of this Agreement extends beyond the County's current fiscal year, this Agreement is conditioned upon and subject to appropriation and availability of funds for that part of the term of this Agreement that extends beyond the County's current fiscal year.


5. The Contractor certifies that this Agreement has been duly authorized and approved by all required organizational action of the Contractor.

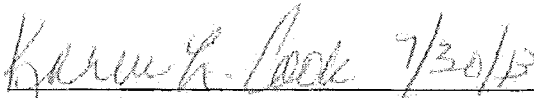

TO ALL OFFERORS: PLEASE NOTE THE FOLLOWING ADDITIONAL INFORMATION:

QUESTIONS:

1. On page 28, Item #30. Should the extended price be 4,000 times the hourly rate? Example $4000 \times \$90 = \$360,000$

ANSWER: Yes

2. On page 24, Item #11 and #12 appears to be the same transmission (GM 3T40). If it is, should only one be filled in?

ANSWER: No: Item #11 has the Torque Converter Clutch option.

3. Pertaining to the towing to and from and quoting a price for that, would all vehicles be towed from the same garage or are there several different ones that will be involved? Mileage/Pricing will determine that in the quote if it is several different places as I see stated in 3.1.2

ANSWER: There are three (3) locations that vehicles will be towed from:

1. MILLERSVILLE GARAGE, 8435 Maxwell Frye Rd., MILLERSVILLE MD
2. GLEN BURNIE GARAGE, 7409 B & A BLVD., GLEN BURNIE MD
3. DAVIDSONVILLE GARAGE, 350 West Central Ave., DAVIDSONVILLE MD

4. In reading the IFB, it seems we are to be separating the price of the transmission from the labor/towing price? If I am reading correctly unit price is only hard

parts being used to build the transmission (unit price) and then times that by the quantity to get the extended price. Then labor and towing price will be entered on Item #30 with an hourly rate times the 4,000 quantity.

ANSWER: All items except for items 30 & 31, are all inclusive, and should include labor for installation and all towing expenses.

5. Item #31 would that be total cost (parts, labor, towing) at the % over cost?

ANSWER: No, just parts and labor.

6. You only have one line listed for a price so I assume it is one style of vehicle that is in the fleet. What kind of vehicle is it for so I can price it accordingly? Also do you want the price of new and rebuilt?

ANSWER: The Transmissions listed in the bid fit a multitude of vehicles. Pricing should be based on rebuilt units.

7. Could you please tell us if it would be acceptable to put county owned vehicles in a garage versus a gated lot?

ANSWER: Inside storage in a garage is acceptable.

8. Would it be acceptable to have a shop that is located outside Anne Arundel county to install units on county owned vehicles?

ANSWER: No, inside Anne Arundel County only.

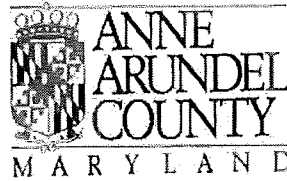

1.21.1.2 The price for each item as offered by the Successful Bidder is, in the County's sole opinion, fair and reasonable and consistent with the pricing for the balance of the resulting Contract.

1.21.1.3 The items added are relatively insignificant to the overall value and services under the agreement.

1.22 MOST FAVORED PUBLIC ENTITY

The Successful Bidder agrees that the prices charged the County under this Contract do not exceed existing selling prices to its other customers for the same or substantially similar items or services for comparable quantities under similar terms and conditions.

SECTION TWO – GENERAL SPECIFICATIONS

2.1 SCOPE

- 2.1.1 These Specifications are intended to cover the furnishing, installation, and delivery of automotive transmissions, and for the repair of transmissions for the Anne Arundel County Department of General Services, Garage Administration, as listed in Section Three and in the attached Bid Response Form.
- 2.1.2 All goods delivered shall be the manufacturer's current models, completely serviced by the Successful Bidder, and shall be delivered ready in all aspects to be placed in normal operating service.
- 2.1.3 Estimated annual usage for this contract is approximately \$80,000 to \$90,000, but is not guaranteed. Quantities listed on the Bid Response Form are estimates for most models listed. Where the quantity is "1", the County has not purchased this model transmission in the last few years.

2.2 BLANKET ORDER RELEASE

- 2.2.1 The agreement set forth is essentially a price agreement and the execution of the agreement or the receipt of a Purchase Order does not authorize the Successful Bidder to deliver or release any material to any department in the County. Authorization for materials to be delivered shall be by Blanket Order Release issued by the Purchasing Agent.
- 2.2.2 Non-Exclusivity: Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. This Contract shall not restrict the County from acquiring similar, equal, or like goods and/or services from other entities or sources.

2.3 TERM OF BLANKET ORDER CONTRACT

This Contract shall be in effect for one (1) year beginning July 1, 2013. This Contract may be renewed up to an additional four (4) one-year periods with the same terms and conditions at the sole discretion of Anne Arundel County, Maryland. After the initial term, any one-year renewals will be subject to the availability and appropriation of County funds.

2.4 WARRANTY AND SERVICE

The Successful Bidder warrants any goods furnished shall be of the highest quality, shall comply with Specifications, and shall be free from all defects in workmanship and materials for at least one (1) year. Any defective goods shall be immediately replaced free of cost to the County.

2.5.4 All items shall be delivered F.O.B. destination and delivery costs and charges shall be included in the Bid Response. Unit prices quoted shall include delivery, all charges prepaid, and shall be exclusive of all taxes. No transportation, shipping, or handling charges shall be added to the invoice.

2.5.5 The County Purchasing Agent reserves the right to charge the Successful Bidder fifty dollars (\$50.00) per working day for each day the goods or services are not delivered in accordance with the delivery schedule. The Successful Bidder may receive orders by phone, facsimile, or other forms of notification from authorized County employees. Statutory benefits as required by Maryland law and, when required, the U. S. Longshoremen's and Harbor Workers' Compensation Act, including standard Other States coverage; Employers' Liability coverage with limits of at least \$100,000 each accident/\$100,000 each employee disease/\$500,000 disease policy limit.

2.11.4 On all Commercial General Liability and Business Automobile Liability Insurance policies, Anne Arundel County, Maryland, its agents, servants, and employees shall be named as an additional insureds, which shall be shown on the insurance certificates furnished to the County under this Section.

2.11.5 The Successful Bidder shall provide the County with Certificates of Insurance evidencing the coverage required above. 2.12 RETURN GOODS POLICY

2.12.1 The County shall apply the following policy to returned goods throughout the term of the Contract. By its signature on the Bid, the Bidder acknowledges it has read, understood, and agreed with the following policy.

2.12.2 Returns generated by the Successful Bidder's error, over shipment, defective merchandise, unacceptable substitution, or otherwise through no fault of the County shall be returned to the Successful Bidder with no restocking charge to the County. - 2.13.3 The County reserves the right to accept, reject, or modify the request for a price adjustment. If the County approves a price adjustment, the price shall remain firm for the renewal term for which it was requested.

2.14 AGREEMENT

Successful Bidder shall review the attached sample agreement and note any issues it may have with the agreement. Upon notifications of intent to award, the Successful Bidder shall have an authorized person (as shown under Section 1.25) sign a similar agreement tailored to meet this IFB as part of the Contract.

2.15 NEGOTIATED PRICING

3.0 SECTION THREE – TECHNICAL SPECIFICATIONS**3.1 GENERAL**

- 3.1.1 Bids shall be accepted for rebuilt transmissions, installed, and transmission and associated equipment repairs at the Successful Bidder's site.
- 3.1.2 Work shall include vehicle pickup and delivery to and from the Millersville Garage, 8435 Maxwell Frye Rd, Millersville, Maryland, the Glen Burnie Garage, 7409-B Baltimore-Annapolis Blvd., Glen Burnie, Maryland, and the Davidsonville Garage, 350 West Central Avenue, Davidsonville, Maryland.
- 3.1.3 Associated repairs include items such as clutch, converter, transmission housing, etc.

3.2 QUANTITIES

- 3.2.1 The County shall purchase rebuilt/remanufactured automobile and light truck automatic transmissions and transaxles from the Successful Bidder during the period of the Contract. The Successful Bidder shall be required to supply and install all transmissions required as specified and at the prices quoted on the Bid Response form.
- 3.2.2 The exact quantity of each type of transmission cannot be determined. The County has assigned a probable dollar value of \$86,000.00 to the Contract on an annual basis based on previous usage, the majority of this for repair work. It is to be understood that the Contract shall not guarantee any specific or estimated quantities.

3.3 GUARANTEE

All transmissions and converters shall be guaranteed in their entirety for a minimum of twelve (12) months with unlimited mileage except in the case of damage caused by collision or other externally affected damage. The Successful Bidder shall be responsible for rebate to the County for any repairs invoiced and paid which are subsequently documented to have been eligible for repair at no cost under the guarantee at the time of repair. Transmissions installed and/or furnished by the Successful Bidder shall not experience a rate of failure during the guarantee period exceeding five percent (5%) of the total number of transmissions purchased by the County within any twelve (12) month period. Failures of transmissions provided under this Contract in excess of five percent (5%) may be cause for termination of the Contract at the sole discretion of the County.

3.4 RESPONSE TIME

- 3.4.1 All installations required by the County under these Specifications and Bid Response shall be delivered within a responsible and reasonable time requested by the County. Responsible and reasonable time shall be defined as no more than seventy-two (72) hours or three (3) working days from time of request by the County. It is expected that most installations shall be completed within forty-eight (48) hours or two (2) working days from the time of request. Bidder fails to render reasonably prompt delivery or furnish transmissions of proper quality, the County may terminate the Contract. The decision of the County shall be final.

- 3.4.2 Requests for service shall be made between the hours of 7:00 a.m. and 4:00 p.m., Monday through Friday, excluding major County holidays.

3.5 BIDDER QUALIFICATIONS (Pass/Fail)

- 3.5.1 The Successful Bidder may be investigated as to organization, ability to perform, and experience. The County reserves the right to reject any bid where such investigation does not satisfy the County requirements as listed below. Negative previous performance on County contracts shall be considered in determining qualification of a Bidder and the decision of the Purchasing Agent shall be final.
