The following revisions and responses to questions are made to the original bid document. This addendum forms a part of the Contract Documents and modifies the Original Solicitation Documents accordingly and as noted below. Acknowledge receipt of this Addendum in the space provided on the "Addenda" form within the Form of Proposal.

#### IMPORTANT:

New Exhibit A – Spreadsheet for BCPS Annual PM Cost per Site pricing included with this addendum under separate cover.

The "Annual PM Cost per Site" portion of pricing for BCPS facilities has been revised to include new school(s) and equipment. This pricing is now requested in an excel spreadsheet (Exhibit A) made available with this addendum under separate cover. Bidders shall submit pricing for "Annual PM Cost per Site" using the excel spreadsheet and disregard the pdf table in the IFB pgs. 85 – 90 of 119.

As a result of this change, your complete bid submission shall contain a pdf of the Form of Proposal with all other BCPS and CCPS price proposal sections and an excel sheet with BCPS "Annual PM Cost per Site", both uploaded via the "Bid/Proposal Submissions" link as provided in IFB Part II, Section 7.0 Bid Submission.

No alterations shall be made to the excel spreadsheet. Bidders that make alterations or add language other than the pricing requested in the highlighted area may be deemed non-responsive.

#### GENERAL

The solicitation inquiries received prior to the issuance of this addendum are as follows:

(1) **INQUIRY:** In pages 00400-9-13,14 of SECTION 004000 "FORM OF PROPOSAL", there is a table that list School names and Annual PM Cost Per Site. What does Annual PM mean (Annual Fire Alarm inspection, Annual Sprinkler inspection, or something different? Please advise what an "Annual PM" is referring to and systems it is covering?

#### **RESPONSE:** Annual Fire Alarm Inspection

(2) INQUIRY: The solicitation states: FIRE ALARM SYSTEMS INSTALLATION, REPAIRS, PARTS, INSPECTIONS and PREVENTIVE MAINTENANCE. Does this solicitation include Fire sprinkler, Pumps, Extinguishers, and fire alarm? RESPONSE: BCPS Fire Alarm System Install, Repair, Parts, and Inspection

(3) **INQUIRY:** The Fire Sprinkler/ pumps/ extinguishers portion only for Charles County Public Schools sites? **RESPONSE:** Yes.

(4) **INQUIRY:** Are there any device counts for the Fire Alarm systems in each school (smoke detectors, pull stations, duct detectors, etc...)?

**RESPONSE:** Yes, BCPS Contract Maintenance has that information; but it is not readily available to provide in this addendum.

(5) **INQUIRY:** Are past inspection reports available for each school? **RESPONSE:** No.

(6) **INQUIRY:** Will BCPS revise the bid form to allow the bidders to provide a separate hourly cost for Sprinkler and Fire Alarm Technicians? As Sprinkler work is required by CCPS. **RESPONSE:** BCPS' portion of the contract is for Fire Alarm technicians only.

(7) **INQUIRY:** Does the Annual Cost for BCPS schools include any testing for Sprinklers? **RESPONSE:** No, this is being handled on a separate contract.

(8) **INQUIRY**: Under Section 004000 Form of Proposal page 5 Item 2C references Fire Mark as a company. We are not familiar with any such Company or Services, please clarify if this is the correct name.

**RESPONSE:** Fire Mark is not installed within BCPS.

(9) **INQUIRY:** Under Section 004000 Form of Proposal page 5 Item 3G references Test - Um as a company. We are not familiar with any such Company or Services, please clarify if this is the correct name.

**RESPONSE:** This is not installed within BCPS.

(10) **INQUIRY:** Under Section 21.4 Response Time please clarify if this statement means partial hourly billing is required and not minimum 1 hour or if the bidder will be penalized by BCPS for being late and actual monetary value will be forfeited to the County.

**RESPONSE:** This section requires no clarification. It pertains to invoicing procedure to be followed if an award bidder fails to meet the response time. Regarding lateness, award bidders shall adhere to this provision. Regarding invoicing, standard practice follows that one (1) hour is billed for work completed within the first hour.

(11) INQUIRY: In Part III Technical Specifications again the bid refers to requirements for BCPS & CCPS they seem to differ in requirements are both requirements required for all locations. **RESPONSE:** Fire alarm Panels and associated devices only for BCPS.

(12) INQUIRY: On the Form of Proposal pages 1-14 reference requirements for BCPS sites and on page 15 - 18 reference CCPS sites. The CCPS sites and pricing seem to be geared towards Sprinkler work and not necessarily Fire Alarm maintenance work. Are bidders required to provide pricing for both sections and if they cannot, will they be disqualified for any and all other portions of the bid, meaning BCPS portions.

**RESPONSE:** It is recommended that bidders submit pricing for both BCPS and CCPS facilities and functions. For BCPS pricing, refer to IFB Section 00-4000-3 Price Proposal Instructions. Otherwise, for CCPS pricing, if no pricing is being submitted for a particular line item, please Indicate by entering "No Bid". Bidders are encouraged to submit pricing for both school systems. However, they will not be disqualified solely for submitting pricing for only one system.

All other specifications and terms remain as stated in the original document. This addendum is hereby made a part of the Contract Documents, on which the contract is based and is intended to modify, explain, correct and/or add to the original Contract Documents.
