RENEWAL- CONTRACT NO. 16-050 FOR INMATE TELEPHONE SYSTEM

- A. Overview This recommendation is to renew a contract with Inmate Calling Solutions, LLC for the purchase of an inmate telephone system. The research conducted by both the Division and Procurement & Contracting determined that a Request for Proposal was the best and most financially sound means for this purchase and final award was unanimously decided by the Evaluation Team to present the best value for the County.
  - a. Solicitation: Advertised on the DP&C website, eMaryland Marketplace and directly emailed to 37 registered vendors.
  - b. Participation: 4 proposals received: Inmate Calling Solutions, LLC Pay Tel Communications, Inc. Securus Technologies, Inc. Telmate, LLC
  - c. Other facts:
    - ✓ *Current contract term:* May 1, 2017 through April 30, 2018
    - ✓ *Renewals:* 3 remaining renewal options (05/01/2018-04/30/2019, 05/01/2019-04/30/2020, 05/01/2020-04/30/2021) exercised at the sole discretion of the County
    - ✓ *Contract value:* Estimated contract value \$190,000.00, but shall not exceed the appropriation.
    - ✓ Administration: Sheriff Charles A. Jenkins, Frederick County Sheriff's Office, 301-600-1532
    - ✓ Type of contract: This is a best value purchase in accordance with Purchasing Rules & Regulations 1-2-25, Competitive Sealed Proposals.Legal review: An Agreement has been signed with the approval of the Office of the County Attorney
- B. Recommendation DP&C Director recommends renewal, with the concurrence of the Frederick County Sheriff's Office, with the previously awarded firm: Inmate Calling Solutions, LLC.
