

CONTRACT ADDENDUM
Airport Self Pay Vending

This Addendum (the "Addendum") is made and entered into as of November 6, 2024 by and between:

1. **Daniels Vending LLC** a limited liability company with its principal office located at 5620 Landing Neck Rd, Trappe, MD 21673 ("Vendor");

and

2. **Wicomico County** a government entity with its principal office located at 125 N. Division Street, Salisbury, MD 21801 ("Company").

WHEREAS, Vendor and Company entered into a contract dated February 8, 2024 (the "Original Contract"); and

WHEREAS, the Vendor has been acquired by **CRH Catering Co. Inc.** (the "Acquirer"), effective as of October 16, 2024 and

WHEREAS, the parties wish to amend the Original Contract to reflect the acquisition and to ensure that the terms of the Original Contract remain binding and enforceable in light of the change in ownership.

Now, therefore, the parties agree as follows:

1. Acknowledgment of Acquisition

The parties acknowledge that as of the acquisition date, **CRH Catering Co. Inc.** has acquired **Daniels Vending LLC** and all rights and obligations of Vendor under the Original Contract are transferred to and assumed by **CRH Catering Co. Inc.**

2. Continuation of Contract

The Original Contract shall remain in full force and effect, except as amended by this Addendum. All terms, conditions, and obligations of the Original Contract shall continue to be binding upon the parties and their respective successors and assigns.

3. Assignment of Rights and Obligations

CRH Catering Co. Inc. assumes all rights, duties, and obligations under the Original Contract as of the acquisition date, and all references to "Vendor" in the Original Contract shall be deemed to refer to **CRH Catering Co. Inc.**

4. No Change in Terms

Except for the substitution of **CRH Catering Co. Inc.** for **Daniels Vending LLC** in accordance with this Addendum, the terms and conditions of the Original Contract remain unchanged and in full force and effect.

5. Notice of Change

6. Effective Date

This Addendum shall become effective as of the date this Addendum is signed by both parties.
